



# JOB TITLE: Disaster Recovery Manager REPORTS TO: VP of Programs

Habitat for Humanity of Greater Los Angeles (Habitat LA) is seeking a qualified candidate to be responsible for direct delivery of Habitat LA home repairs and rebuilding programs for low- and moderate-income households affected by community disasters. This includes participation in both VOAD and Long-Term Recovery Group (LTRG) meetings, committee work, and receipt of referrals approved for construction through established systems. Community outreach, application origination and processing, homeowner case management, homebuyer counseling and supervision of AmeriCorps, interns and volunteers are essential duties.

# SUMMARY OF ESSENTIAL FUNCTIONS

- Process program applications and qualify eligible households to meet program goals
- Ensure clients comply with all necessary program criteria
- Oversee file management system
- Track disaster clients via Home Keeper and jointly used file tracking systems
- Provide housing counseling and work with households to create personal and construction budgets identifying gaps
- Manage and facilitate regular contact with clients
- Engage clients before, during and after the delivery of services to provide effective case management
- Together with Disaster Case Managers, track, monitor and assess client progress throughout program participation
- Work with clients to resolve issues during their participation.
- Assist clients with post-participation issues
- Establish and maintain collaborative working relationships with local social service agencies and providers
- Implement outreach and marketing strategies to identify qualified program participants through the LTRG and directly
- In conjunction with senior staff, supervise AmeriCorps Members, interns and program/office volunteers and construction volunteers as needed

- Knowledge of low-income housing programs, state, county and federal program requirements (HUD);
- Acquire and maintain HUD Housing Counselor Certification and recertify when needed
