

CalHome Disaster Assistance Loans Prequalification Questionnaire

In partnership with the State of California Housing and Community Development Department (HCD), Habitat for Humanity of Greater Los Angeles (Habitat LA) can provide deferred payment loans to homeowners whose homes were damaged or destroyed in the 2017 or 2018 Los Angeles wildfires.

Loan Terms

- The maximum loan amount per household is \$150,000.
- Loans will have a 20 or 30-year term.
- Loans can be used for traditional builds, manufactured homes, and mobile homes not affixed to a permanent foundation. They can also be used to build or repair an Accessory Dwelling Unit (aka Granny Flat).
- Loans will be in the form of deferred payment loans, repayable upon the sale or transfer of the home, when they cease to be owner occupied, or upon loan maturity date.
- Simple interest will accrue at the rate of 1.5% per annum on the unpaid principal balance.
- Beginning on the 11th year anniversary of the loan, 5% of the accrued interest amount will be forgiven annually on the loan anniversary date provided that the property remains owned and continuously occupied by the borrower.

Eligibility Criteria

- Applicant(s) must own a property that was damaged or destroyed in the 2017 or 2018 Los Angeles wildfires FEMA disaster declaration numbers: DR4344, DR4353, DR4382.
- The property must be owner-occupied and the primary residence of all owners on title.
- Homeowner(s) must either be a U.S. Citizen or a Permanent Legal Resident.
- Household income must be below 120% of the area median income (AMI) for Los Angeles County as indicated by HCD within the given year applied. See table below.

Application Process

- Homeowner submits this Prequalification Questionnaire.
- Habitat LA reviews applications for completeness and eligibility.
- If household appears eligible based on information given, Habitat LA will invite the homeowner to submit a full application and submit additional documentation.
- Habitat LA reviews full application and submitted documentation to verify eligibility.
- Habitat LA visits property, if necessary.

Please complete all sections of this questionnaire. Upon review and confirmation of the information provided, you will receive a status notification on your submission. The CalHome Loan Program is dependent on the availability of funding. Therefore, not all eligible applicants will be selected.
